### PERMISSION TO USE FORM

As the property rights holder, the Postal History Foundation charges a permission fee for images used in any commercial publication, broadcast, website, exhibition, promotional material, etc. **Fees for commercial use or publication will be determined on a case by case basis.**

### POLICIES GOVERNING PUBLICATION:

- **Copyright:** The researcher assumes all responsibility for identifying and satisfying any claimants of copyrights and for observing applicable laws regarding intellectual property. The recipient agrees to indemnify and hold harmless the Postal History Foundation, its officers, employees and agents from and against all suits, claims, actions and expenses arising out of the use of reproductions provided by the Postal History Foundation.
- Permission to publish requires the proper completion of the attached *One Time Usage Agreement* form, and approval from the Postal History Foundation Library/Archives Department.
- When permission is granted and use fees are paid, the grantee is entitled to a **one-time, non-exclusive**, use of the photograph(s) listed separately. *Additional uses must be negotiated* and approved before use. Additional use includes but is not limited to: multi-language editions, trade, promotional, packaging, advertising, or use in electronic format, including but not limited to internet or other usage.
- No photograph(s) obtained from the Postal History Foundation may be copied, resold, or brokered for profit, nor deposited in any library or collection without first obtaining specific written authorization from the Postal History Foundation.
- The researcher must supply precise information on the materials to be published and the publication in which they are to appear. For individual photographs with an accession number, credit should read: *Postal History Foundation*. Credit for manuscript materials and photo collections shall be given as follows: *Postal History Foundation*. If a detail of an image is being published, please note in caption.
- **INTERNET USE WILL BE DETERMINED ON A CASE-BY-CASE BASIS.** Images posted on the internet will have maximum resolution of 72 dpi and be no larger than 600x400 pixels in dimension. The Postal History Foundation reserves the right to remove its images from any website.
